**To be eligible to receive one of the above awards the following criteria must be met:**

**Small Business Person of the Year:**

- Individuals who own or operate a small business. (Fewer than 100 employees)
- Have an established and viable business located in the Greensboro area. (Business must be at least two years old)
- Show growth in employees and/or sales volume.
- Response to adversity.
- Community Service.
- Involvement in Greensboro Chamber.

**Minority Small Business Person of the Year:**

- Minority individuals who own or operate a small business. (Fewer than 100 employees)
- Have an established and viable business located in the Greensboro area. (Business must be at least two years old)
- Show growth in employees and/or sales volume.
- Response to adversity.
- Community Service.
- Involvement in Greensboro Chamber.

**Small Business Advocate of the Year:**

- Individuals who provide technical assistance to small businesses or supporters of entrepreneurial development.
- Have a distinctive level of technical assistance or service.
- Promote small business as a significant form of economic development
- Written or spoken advocacy for small business issues and initiatives.

**Outstanding Employer of the Year: (circle: small medium large)**

- Recognizes employers who demonstrate outstanding achievements towards improving employment opportunities for people with disabilities.
- Given to employers with an exceptional record of hiring and/or facilitating employment for people with disabilities, and that have made efforts toward a barrier free environment.

**Media Award (circle: Print Broadcast)**

- Recognizes and honors excellence in media materials concerning the empowerment and employment of people with disabilities.
- Given to an Individual or Organization in the field of Media that has shown positive representations of people with disabilities in situations or activities that reinforce empowerment, inclusion and mainstreaming.
